² In late 2018, it was discovered that an inadvertent reporting error that had been undetected for some years had resulted in the misreporting of cumulative data. The Second Circuit thereafter undertook an exhaustive and detailed review of all relevant data going back to 2015 and revised the reported statistics from 2015 to the 2017. The data reported here are accurate as a result of that review and correction.
